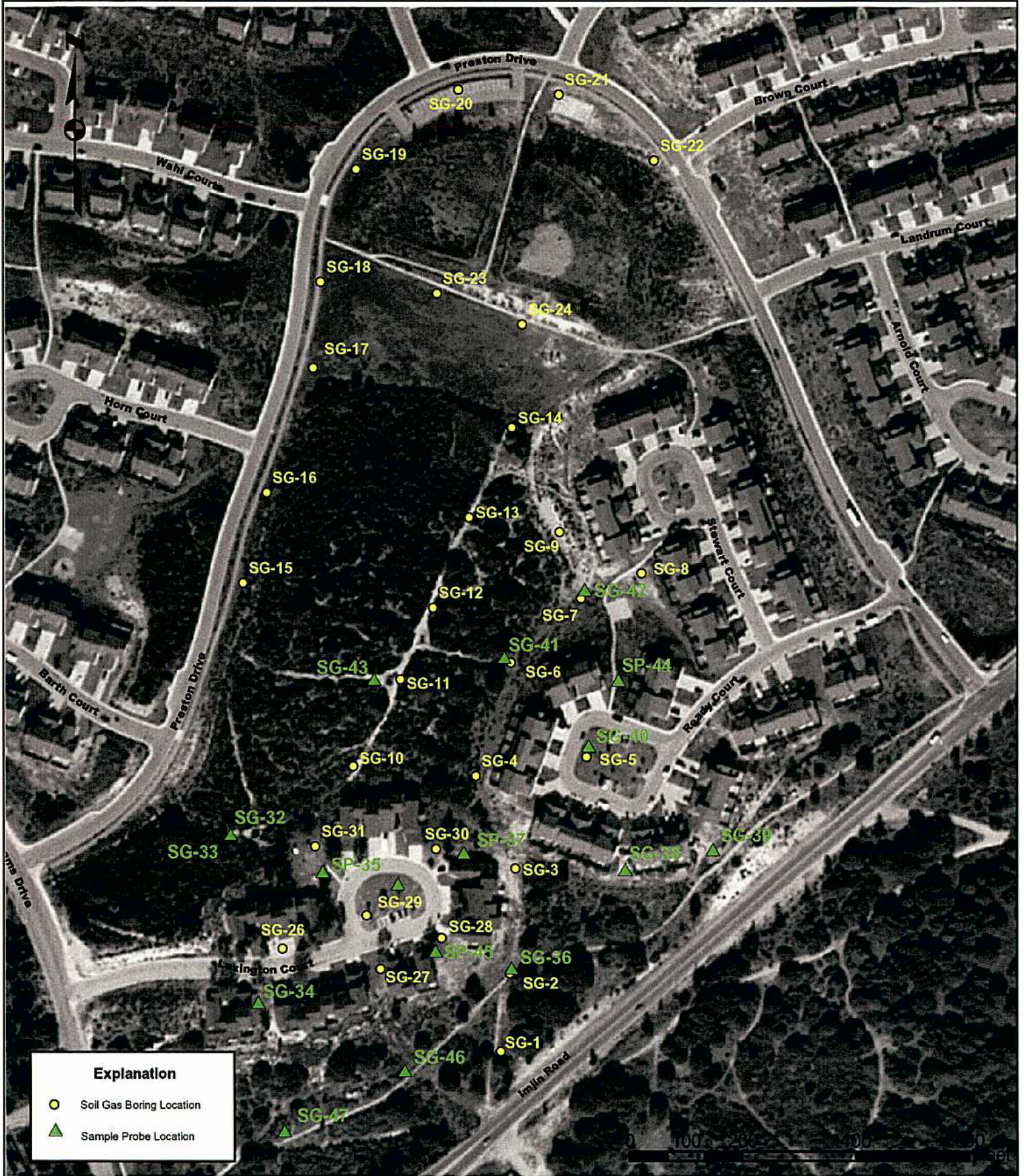

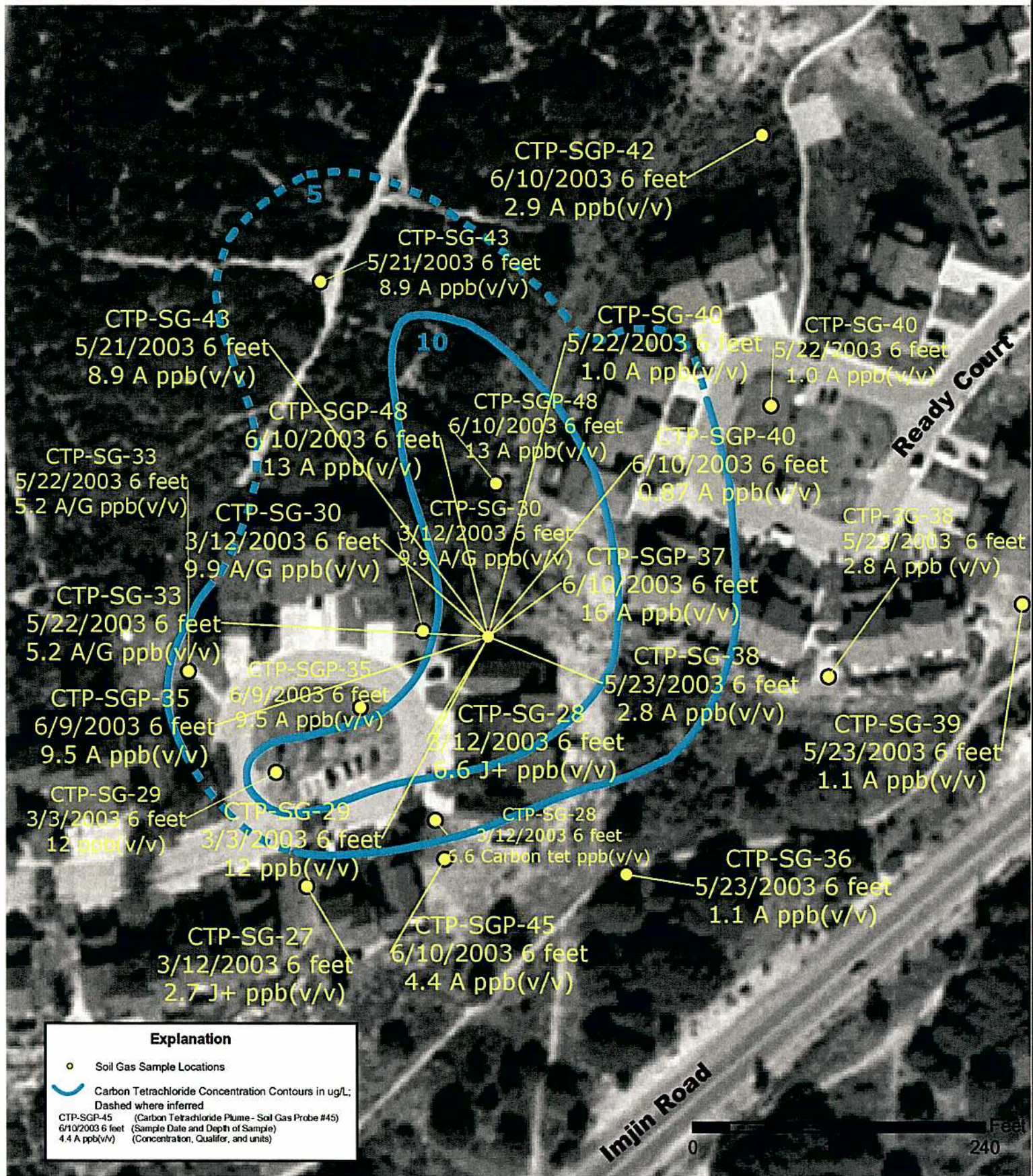

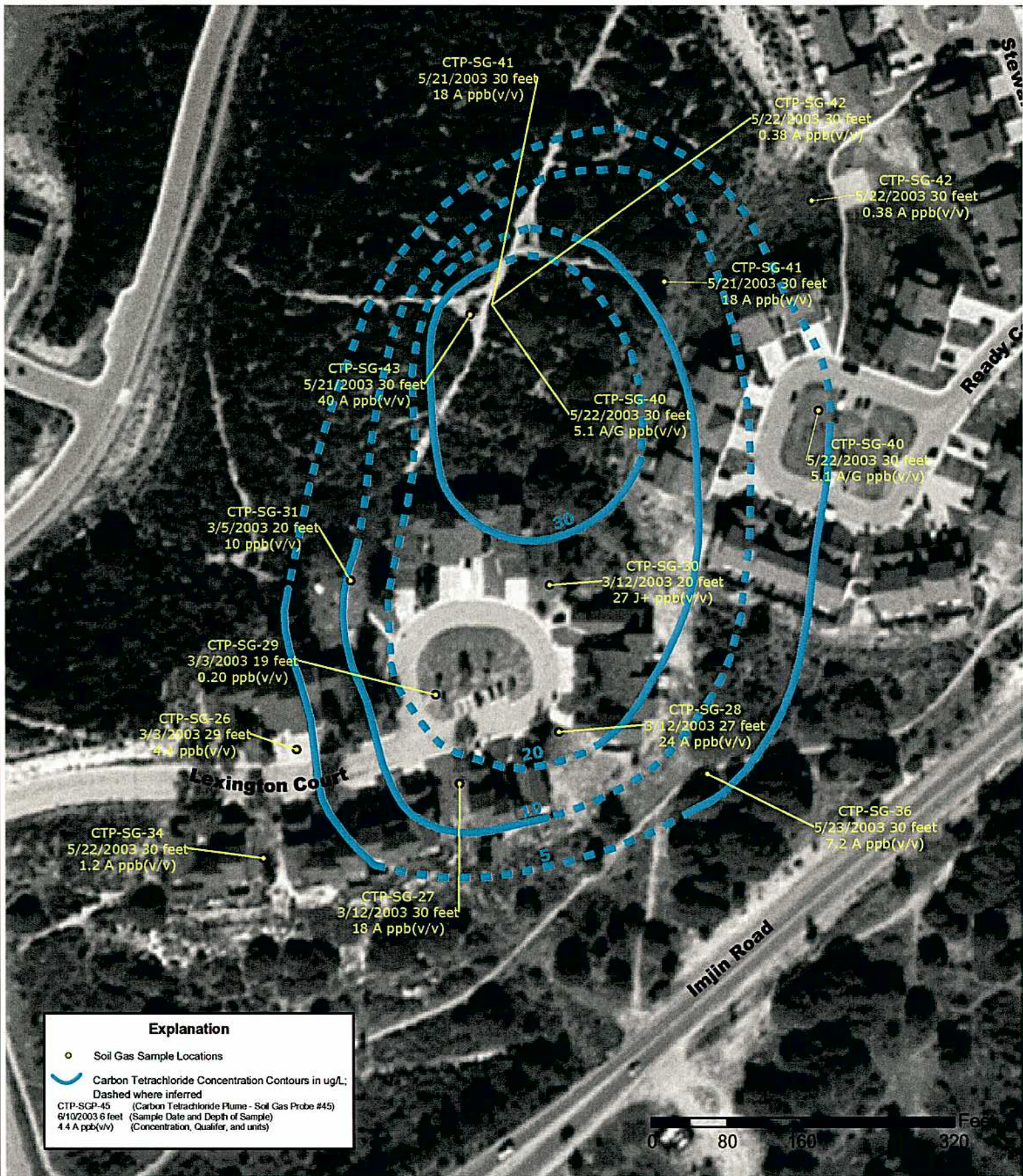

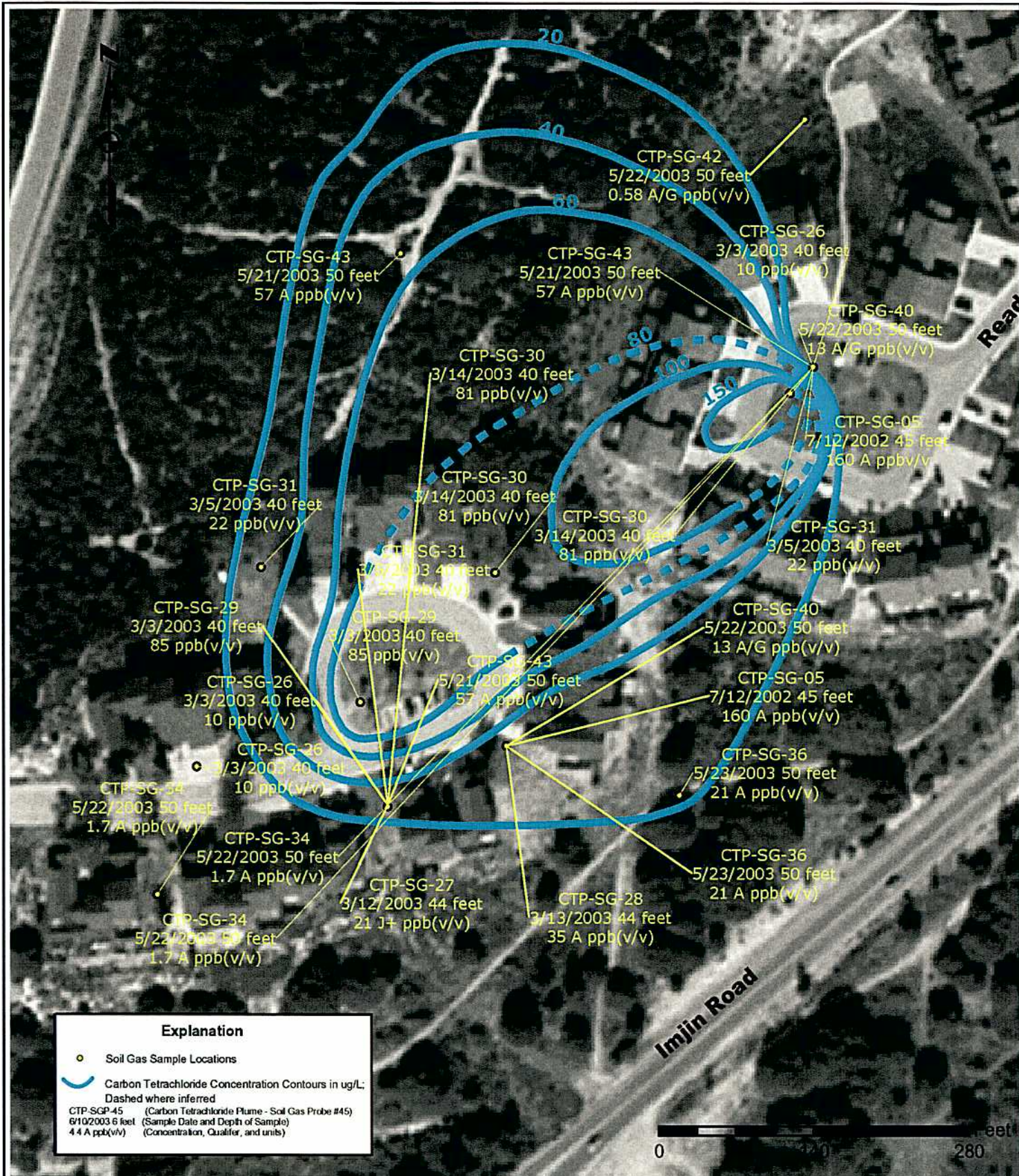

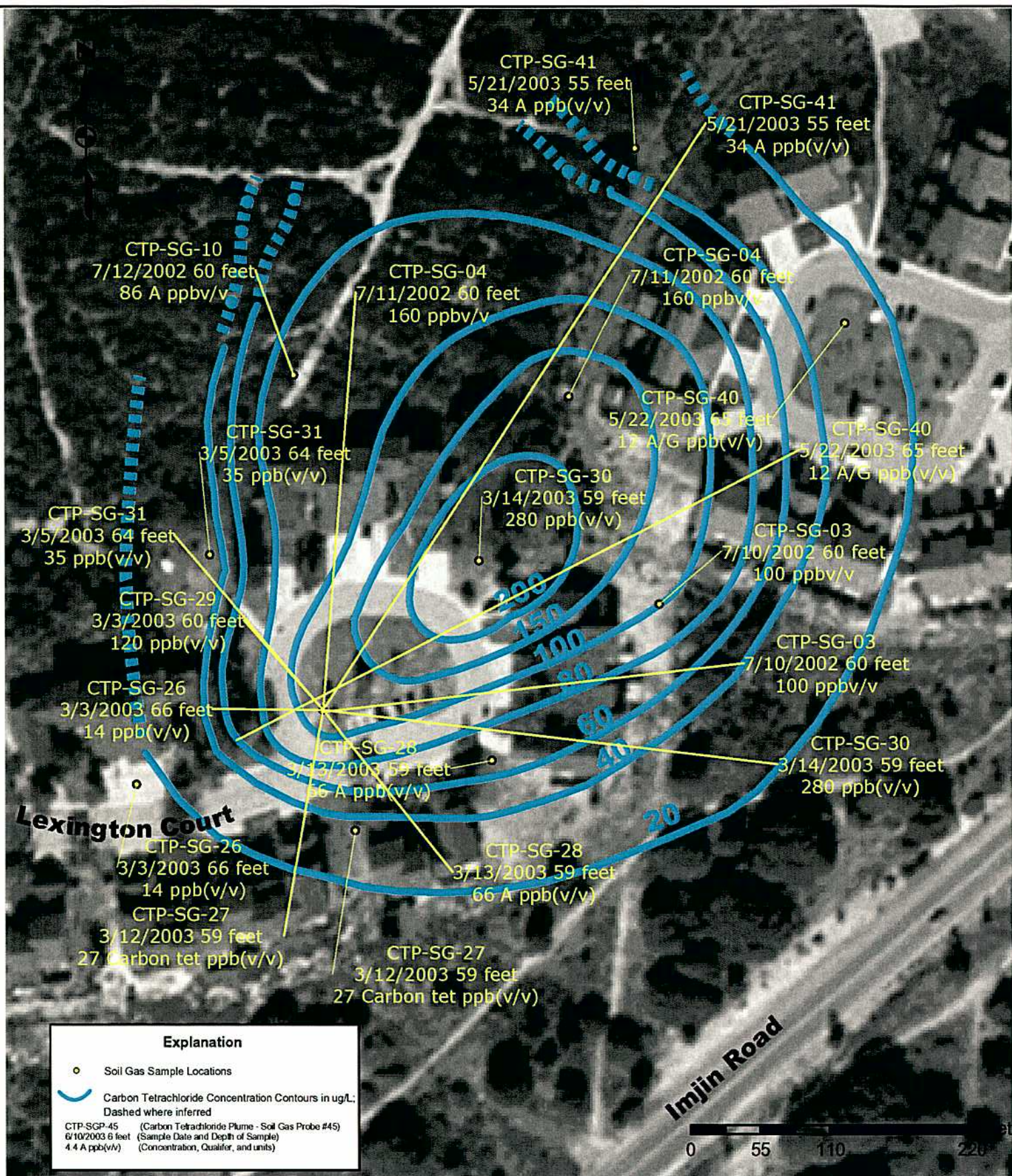
**Carbon Tetrachloride Concentrations in Soil Gas
